Methodology covers entire terrain of scientific research in the social sciences. For an approach to qualify as a social scientific methodology it must meet four criteria, one it must define the subject matter of the social sciences. Second, it must explain how that subject matter is constituted, that is how the 'facts' of social sciences become 'facts'. Third, it must provide social scientists with precisely defined conceptual tools and procedures and fourth it must define the limits of the social scientific activity. Therefore, an understanding of methodology which is different from methods of social research will enable the social investigator to transcend the technician's role and obtain the role of the research scientist. The specific objectives are:

- To understand the nature and the philosophy of the social sciences in general and sociology in particular.
- To understand the relationship of sociology with other sciences.
- To understand the methodological debates in classical sociology
- To understand the major methodological debates in Indian sociology
